
2022 AIA|SB Design Awards Submission Guidelines

In recognition of individual architects and architectural firms who have made a substantial contribution in the field of architecture in our region and around the world, this award celebrates excellence in design that goes far beyond the practice of architecture. Great architecture is about creating an enduring legacy, inspiring people and enriching their lives. Innovative buildings can help shape the way we live and enable us to make the most of the limited resources we have.

AIA|SB's Design Awards reflect the values and aspirations of our region's design community while focusing on larger, even global design issues. We recognize that our members work on a variety of challenging projects of every scale. Submissions should reflect a strong sense of place, history, and purpose. We value artfully resolved design and celebrate the fact that good design offers new solutions to new challenges.

All submissions must demonstrate clarity of idea, process and execution through a combination of text, diagrams, drawings, photographs, and other illustrative materials as outlined in these submission guidelines. The Jury will rank each submission as to how it meets the criteria in Section V of this packet.

The Jury reserves the right not to make an award in any particular category. Each category may be awarded an Honor, Merit or Honorable Mention. The Jury may award multiples of the same type in any category in the case of ties among submissions.

Chapter staff shall ensure that projects remain anonymous. Please refer to AIASB's statement on Conflict of Interest included herein.

I. Schedule

Call for Entries: May 3, 2022

Early Bird Registration deadline: July 22, 2022

Final Registration deadline: August 12, 2022

Submission deadline: September 2, 2022, *Entries shall be uploaded / delivered no later than 9.00 PM, PDT*

Jury Convened: October 2022

Design Awards Ceremony: TBD December 2022

II. Eligibility

Licensed architects or firms in good standing membership of AIA|SB are eligible to submit projects. Projects may be located within Santa Barbara County or worldwide. Non AIASB chapter members may submit projects as long as the submission is located in Santa Barbara County. Projects previously awarded by the AIA|SB design awards program are not eligible. Members of the 2021 Design Awards Committee who intend to submit a project for consideration are not eligible to participate in juror selection or deliberations.

III. Entry Fees

AIA|SB Members:

Early Bird Registration **\$175** (\$150 each additional entry,) **\$100** for entries previously submitted, but not awarded.

After July 22, 2022: **\$225** (\$200 each additional entry,) **\$150** for entries previously submitted, but not awarded.

Non-Members: **\$270** (\$250 each additional entry,) **\$200** for entries previously submitted, but not awarded.

NOTE: ENTRY FEES ARE NON-REFUNDABLE

IV. Categories

Entrants should carefully consider selecting the most appropriate category for their submission. Projects may be entered in more than one category. To enter in more than one category entrants must register the project separately in each desired category for an additional fee (as an additional entry) (i.e., Commercial Buildings and Santa Barbara Style, etc.) Once submitted, entries cannot change categories.

Submissions must be projects designed or completed within the previous 10 years (2011-2021.)

Consideration should be given to projects that are in response to the current COVID Pandemic.

Honor, Merit, and Honorable Mentions may be recognized in the following categories:

1. Commercial Buildings

Excellence of design in projects of commercial, institutional or industrial uses. This category includes new buildings, substantial remodels and additions. Commercial Interiors shall be submitted under Category 7 below.

2. Single Family Residential

Excellence of design and construction in single family homes. This category includes new buildings and extensive remodels and, or additions (greater than 60% of the original building.) Residential Interiors shall be submitted under Category 8 below. This category may also include an Accessory Dwelling Unit (ADU) project, if the main residence is part of the score of work.

3. Mixed Use and Multi-Family Residential

Excellence of design and construction in structures containing two or more dwellings units. This category includes Mixed-Use buildings containing both residential and non-residential uses. Accessory Dwelling Unit (ADU) project shall be submitted under Category 6 below.

4. Conservation Projects: Historic Preservation, Restoration, Rehabilitation or Reconstruction

This category is open to all projects that use the Department of Interior (DOI) Standards for the care of Historic Properties; this includes: Preservation, Restoration, Rehabilitation or Reconstruction. Projects should be eligible for listing as structures of merit, landmarks and existing structures that are a minimum of fifty years old. This category may include new buildings

that are part of a project that includes an historic structure as long as that historic structure is incorporated into the scope of work. Submission must demonstrate how the DOI Standards were met in the design solution.

5. Santa Barbara Style (Residential and Commercial Projects)

Projects in Santa Barbara's time-honored Spanish-Colonial Revival Style are eligible to submit in this category. Projects should clearly demonstrate this unique and established architectural heritage. Projects may include new, remodels, renovations or additions, and must demonstrate how the original was either enhanced or converted to Spanish Colonial Revival.

6. Small Projects: Single Family Residential Additions, Remodels or Accessory Dwelling Units (ADU's)

The Small Projects awards category strives to elevate public awareness of the value of design that architects provide to small scale or scoped projects. Projects may include residential additions, remodels (area of work less than 60% of original building) and Accessory Dwelling Units. Small Projects up to 1,200 SF with a construction cost not to exceed \$500,000.

7. Commercial Interiors

Excellence of design and construction in commercial interior architecture and design. This category only includes interiors that have minor exterior scope of work; i.e. exterior window alterations or treatments to enhance the interior displays.

8. Residential Interiors

Excellence of design and construction in residential interior architecture and design. This category includes residential interiors, kitchens, baths or other interior work. The scope of work may include minor exterior alterations as part of the interior work.

9. Proposed/Unbuilt Project

There are many projects that get left on the drawing board and are not constructed for various reasons. These projects often can be compelling and innovative. Projects submitted in this category can be of any type, scale, or location as long as the lead design firm is located in Santa Barbara County and the project has not since been constructed and there are no plans for construction.

V. Submission/Jury Criteria

NOTE: AIA and AIACA are moving toward the required use of the *Common Application* in the submission of awards programs. The *Common Application* is an Excel Worksheet that provides an overall score across ten measures. AIASB will be required to base its Awards Program on the *Common Application* in the near future. The Common Application can be found at the end of this document for reference. As a first step, we have provided reference to the measures of the *Common Application* in each of the judging criteria below.

Your submission should demonstrate the follow measures of excellence:

- 1. Inspiration:** Does the project tell a story about innovative architectural design that is relevant and inspiring? Is the design well-resolved, given the stated project program? Do the materials presented articulate the ambitions of the design?
Common Application: Measure 1 *Design for Integration*. Measure 7 *Design for Wellbeing*. Measure 10 *Design for Discovery*.
- 2. Creative Problem-Solving:** What unique problems was the project asked to address regarding: site, budget, program, materials, collaboration or context? Did it address these requirements successfully? Is the relevance and value of design thinking evident in the submission? Do the presentation materials clearly depict the program, context and organizing principles influencing the design?
Common Application: Measure 5 *Design for Economy*.
- 3. Environmental Sensitivity:** Does the project exhibit serious intent to minimize negative environmental impacts and enhance the natural environment? Are metrics, narratives, diagrams, sketches or other clear evidence provided of both modeled and actual performance? This may also include project submissions in response to the COVID Pandemic.
Common Application: Measure 3 *Design for Ecosystems*. Measure 4 *Design for Water*. Measure 6 *Design for Energy*. Measure 8 *Design for Resources*.
- 4. Social Transformation/Response:** How does the project respond to its social, historical and physical context? Is it sensitive to its physical, social and historical context? Does the project improve the community in which it is situated? Does it exemplify a commitment to enhancing livable communities?
Common Application: Measure 2 *Design for Equitable Communities*. Measure 9 *Design for Change*.

VI. Submission Process

Upon registration, AIA|SB shall email entrants an entry ID (to ensure anonymity during the judging process) and a password for uploading entries to the AIASB Dropbox.

1. Submissions reviewed for compliance to the requirements in this packet. Entries shall be uploaded no later than 9.00 PM, PDT per submittal dates above.
2. Submissions organized for the Jury review.
3. Jury review of submissions.
4. Jury Selection of Awards
5. Presentation Boards requested
6. Design Awards Ceremony, December 2022

VII. Submission Requirements

Each submission shall contain the following in a single PDF file. (see page layout thumbnails on page 5: Section VIII)

1. Entry PDF

A single PDF document formatted 8.5”x11”, landscape format, no larger than 9 MB, a **maximum of 18** pages. **The file name of this document should be “Entry” followed by your entry category initials and ID #** (i.e. Entry-SR-707.pdf). *Please do not indicate any individual, firm, consultant, builder, owner, address, etc. in any of your entry material unless otherwise indicated.* Each entry PDF deliverable shall contain the following sections:

1A. Written Section

The cover page of the document should include a signature shot of the project and may include up to three thumbnails. Page two will include a 36-word statement that tells the jury why you believe the project should be awarded. This page will also include a 252-word description of the project. Please be clear and concise. Subsequent pages may include text and thumbnail images that support the main image and project story.

1B. Drawing Section

A minimum three pages which contain at least: a site/floor plan showing the project and its context, exterior elevation(s), and building section(s) sufficient to explain the solution. Include a graphic scale on all drawings. Additional drawings may be included at the discretion of the entrant, provided the 18-page maximum is not exceeded. Projects in the Interior Architecture categories may omit the Site Plan drawing

1C. Photographic Section

Each entry shall include a minimum of four principal images, one image per page. This page may include smaller thumbnails that support the principal image. This section shall follow the drawing section. Additional photographic pages may be included at the discretion of the entrant, provided the 18-page maximum is not exceeded.

2. JPEG IMAGES

Entrants shall submit up to five separate JPEG images at 300 DPI resolution suitable for clear projection at 1080p, but no larger than 3 Megabytes each. These images may contain the architect/firm’s name and logo, as they will not be used as part of the juried entry. Each image file shall be titled CATEGORY INITIALS-ID#_JPG# (i.e. SR-707-JPG01.jpg). The AIA|SB retains the images for its collection and use and submission shall be considered license for use by AIA|SB.

3. Photography Release Form

A Photography Release Form is included in these Guidelines. A separate PDF file of the completed form(s) for that entry shall accompany each entry at the time of submission. A separate release form shall be provided for each photographer in the case of multiple photographers for a single entry. The name of this document shall be Photographer Release-CATEGORY INITIALS-Entry ID#-.PDF





- *Some of the presentations could have been improved and if presented in a different way, might have been eligible for an award. A number of projects presented had maybe too casual of an approach in telling the story of the project. The crafting of the presentation is just as important as the crafting of the building design.*

Jury Suggestions:

- *Show a complete story of the project, which includes showing enough of the project's surrounding environment*
- *Part of telling the story is two (2) fold: it's to show the context / situation in which you are operating in and to clearly define what the challenges are and how are you solving them in a creative and innovative way. Show it graphically; show it pictorially, it doesn't operate as an object in space – whether it's part of the city, or landscape or urban environment or all of these simultaneously.*
- *Don't lead out with a building plan or a site plan. Lead out with the best image you have. That communicates the aspirational aspect of a project.*
- *Your drawings need to be more than something taken out of a BIM or CAD file. The drawings need to be reproduced (or redrawn) as presentation drawings for this compressed thumbnail presentation.*
- *Projects should be accompanied with diagrams to help the jury to understand some of the primary issues that you are resolving, like organization or proportions, nature, or special adjacencies, etc. This will help the jury get below the surface of the project and not just merely the graphical aspects.*
- *Indicate in the narrative the challenges you were faced with, rather than just describe what you did. The jury needs to know what you are trying to solve (restrictions and requirements were and how did you solve them.)*

AIASB Statement on Conflict of Interest

Included in the 2022 AIASB DESIGN AWARDS SUBMISSION GUIDELINES package is a statement related to the purpose of the AIASB and an excerpt from the Chapter's / Component's policy on Conflict of Interest.

Purpose

The Santa Barbara Chapter American Institute of Architects (AIASB) is a not-for-profit corporation organized and existing under the laws of the State of California for the purposes of conducting operations and activities as an organization eligible for tax-exempt status under Section 501(c)(6) of the Internal Revenue Code. The purpose of this Conflict of Interest policy is to protect the interest of the AIASB when it is contemplating entering into a transaction or arrangement that might benefit the private interest of an officer, director, committee chair, committee member, chief employed executive, chief employed finance executive, or other employed staff. This policy is intended to supplement but not replace any applicable federal or State of California laws governing conflict of interest applicable to nonprofit mutual benefit corporations.

Conflict of Interest

A conflict of interest arises when a person in a position of authority over an organization may benefit financially from a decision he or she could make in such capacity, including indirect benefits such as to family members or businesses with which the person is closely associated.

As many of you know, the AIASB relies heavily on its Board of Directors and other local members of the Chapter / Component who donate considerable time and effort into sitting on and leading various Committees throughout the year. These people are the backbone of the many programs and tours which, in turn, expand on the foundation built by those who have helped this Chapter continue to succeed and raise the bar each and every year. This cannot be done without the help of many, and we are eternally grateful for those who are currently engaged with the Chapter and especially those who have been involved in the past. We could not be here without you. Thank You!

In order to ensure that the 2022 AIASB Design Awards Program is both transparent and fair to everyone that submits a project(s) we feel it is important for all members and/or entrants to be aware that there may be members of the Chapter and/or the Design Awards Committee that have the opportunity to submit projects each year and MAY do so this year. Therefore, the Chapter and the Design Awards Committee members shall be held to the strictest integrity around the Conflict of Interest definition above. In an attempt to assuage any concerns from other members/entrants, the Chapter and the Design Awards Committee have adopted the following best practices:

- Any member of the Chapter or Design Awards Committee that is intending to submit a project will NOT participate in the selection of the Jurors for the Design Awards Program. Typically, the selection is discussed by members of the Design Awards Committee and then personal invitations are made to the prospective Jurors. Any member of the Design Awards Committee who intends to submit projects to the Design Awards Program will recuse himself/herself from this Jury selection process as well as any invitations to prospective Jurors.
- NO member of the Chapter or Design Awards Committee that is submitting projects will participate in or be included in any Juror Meetings, Juror Discussion, Juror Decision nor will they have any knowledge of the results prior to the Design Awards Gala in December 2022. The Design Awards Committee will elect one person from the Committee or the Chapter to work directly with the Jurors as their Liaison and point of contact during this year's Design Awards Program. This person, along with the Chapter's Executive Director and Assistant, will help facilitate the Jury process and support the Jurors for a successful Design Awards Program.
- The person identified above will support the Chapter's Executive Director and Assistant with taking in submittals from entrants, organizing the file system and managing the organization of the entrants and projects. No other member of the Chapter or Design Awards Committee will be involved with this area of the Design Awards Program to ensure sensitive information is not disclosed to ANY other member of the Chapter or Design Awards Committee.

- At times, the number of entrants will be discussed at Chapter Board Meetings by the members and/or the Design Awards Committee. The number of entrants will be the only information reported to ensure full confidentiality of the members. This number will be supplied by the Executive Director ONLY and presented to the Board at regularly scheduled Board Meetings. Minutes and Records will be kept as standard practice and will be available should anyone have a concern about what was presented at the Board Meetings.

Please note that every precaution will be taken to maintain the utmost privacy and a fair playing field for the Design Awards Program. It is our promise to our contingency to make sure that we remove any chances for a Conflict of Interest during this process.
